NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to, and they shall be deemed to form and be read and construed as part of this agreement.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- The Letter of Acceptance issued by the Hospital Authority.
- The Notice Inviting Tender
- The supplier's bid including enclosures, annexures, etc.
- The Terms and Conditions of the Contract
- The Schedule of Requirement
- The Technical Specification
- Any other document listed in the supplier's bid and replies to queries, clarifications issued by the Hospital Authority, such confirmations given by the bidder which are acceptable to the Hospital Authority and the entire Addendum issued as forming part of the contract.

3. In consideration of the payments to be made by the Hospital Authority to the Outsource Agency as hereinafter mentioned, the Supplier hereby covenants with the Hospital Authority to provide, the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Hospital Authority hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
